

STEM OPT Extension Information

STEM (science-technology-engineering-math) OPT extension eligibility requirements:

- 1. Completion of NMSU degree.
 - (You must submit a copy of NMSU transcript and diploma with STEM OPT extension application.)
- 2. Less than 90 days of unemployment during initial OPT period (calendar days).
- 3. Employed by an E-verify employer

If eligible for the STEM extension, complete the STEM OPT Extension Request Form and submit to International Student & Scholar Services. When the new I-20 is ready, you can request for it to be mailed to your home address. You will need to include a copy of the signed I-20 with original signature in your STEM OPT extension application packet mailed to USCIS.

<u>Mailing</u>

Your I-765 STEM OPT extension request will be mailed to a specific USCIS Service Center based on your current address. (See attached addresses). Your STEM OPT extension packet can be submitted a maximum of 90 days prior to the end of your current OPT. The deadline for receipt of your application at USCIS is the ending date of your current OPT as stated on the EAD. If you meet this deadline you can continue working for up to 180 days pending receipt of the new EAD.

Check list, include in your packet:

_____ Original, completed <u>I-765 form</u>

- #27: code for STEM extension is (C)(3)(C)
- #28a-c: add degree, employer name and E-verify number
- _____ New I-20 with requested STEM extension
 - **Remember to sign your I-20 before sending in your application packet.
 - Your new I-20 will state the name and address of your current employer.
 - If you are changing employers prior to the start of your STEM extension, contact ISSS.
- _____ Copy of your NMSU transcript and diploma
- _____ Copy of current EAD
- _____ Two colored passport-style photos
- _____ Photocopy of I-94, (front & back), travel visa, and passport identification page
- _____ Check or money order for \$410 payable to U.S. Department of Homeland
- _____ Security Form G-1145 (this form is optional)

During your OPT extension period you need to report to ISSS if:

There is a change in your home address (report any address changes within 10 days).
If there is a change of employment: send company name, address and starting date of this position.
